



Aussie Pet Mobile - River Oaks Pet Release Form

AUSSIE PET MOBILE® & Texas state law requires your pet(s) to have current rabies vaccination for every pet being groomed. Please confirm that your pet(s) are all current on their rabie's vaccination and that the rabies certificate is available for inspection. While AUSSIE PET MOBILE® adheres to a stringent sanitation procedure for all pet mobiles and equipment, we also strongly advise that each pet be vaccinated against distemper, hepatitis, parainfluenza adenovirus type 2, parvovirus, corona, leptospirosis, and bordetella prior to being groomed.

AUSSIE PET MOBILE® has the right to refuse grooming any animal that may be a threat to itself or any person. If we are not able to take a cat out of its carrier or use a muzzle on a dog that may bite, then we may have to refuse it for its own protection and ours. The pet may get away or get injured if it is undergoing a great amount of stress. It is company policy that owners/caregivers are not allowed in the van without our consent. If you are in the van, AUSSIE PET MOBILE® is not responsible for any injury you sustain that is or is not a result of our negligence.

AUSSIE PET MOBILE® does not use any type of tranquilizers on any pet.

AUSSIE PET MOBILE® Authorization for Shaving a Pet and /or Flea & Tick Treatment

Shaving a pet often exposes pre-existing skin conditions. If an animal is badly matted, you may find sores and tender skin under those mats. Many times, the skin is so sore that the clippers may cut the skin, especially while taking mats off a cat that has very thin skin. There is no way to avoid this no matter how slow or careful we are. The AKC recommends against shaving double-coated dogs. Understand that heat tolerance in double-coated dogs may be reduced and the fur may not grow back to its original condition.

We also use natural and commercial, vet approved solutions and procedures to treat your pet for fleas and ticks. We do not use harsh chemicals or flea type shampoo to kill the fleas. However, some animals may be sensitive to these solutions and procedures we use and may experience an allergic or other reaction that could be serious. If we notice any problems with the animal, you will be notified immediately.
